It is approved by the Department of Higher Education, Govt. of Odisha and affiliated by the Madhusudan Law University Cuttack. It has got permission from the Govt. of Odisha for opening 3 years LL.B course, 5 years B.A LL.B (Hons) (Degree course) and Master of Laws (LL.M) two years programme, Semester pattern( under choice based credit system) from the current session.

### **THE AIMS & OBJECTIVE OF THE LEGAL EDUCATION ARE:**

- a) To produce young talented graduates specially in the field of law to shoulder social responsibility for the maximum good of the community.
- b) To spread awareness in all fields of law and to make the students conscious of the rule of law for a better democratic way of life in the community.
- c) To develop a sense of oneness and development with the rest of the community and inculcate the ideal teaching for high ethical standard during the scholastic career of the students.
- d) To educate the community in the field of better norms for a better creative and cohesive standard of the living through a code of conduct based on sound legal foundation.
- e) To establish and maintain legal Aid clinic wherever suitable to Aid the requirements of the indigent citizens and weaker sections of the community in securing legal Aid to establish their rights as against individuals and the state.
- f) To impart practical knowledge to the students in handling day to day difficult problems facing the individuals in particular and the society at large in securing individual and social justice in courts, tribunals, forums and other authorities.
- g) To carry out research in the field of law to serve the community in bringing forth new ideas and imparting new talents to serve the common good of the community.
- h) To organize seminars, workshops, Debates and Discussion and Training camps in different branches of law to shoulder any responsibility which may develop in the day to day fast moving Indian society and to bring new ideas in the field of legislation.

### **ELIGIBILITY FOR ADMISSION:**

1. The college offers 3 years Bachelor of law course semester system, 5 years B.A LLB (Hons.) Degree course and Master of Laws (LL.M) two years programme (semester pattern).
2. **(a)(i)** A Candidate is eligible to apply for admission into three years **LL.B** Degree course after obtaining the Bachelor Degree from a recognized university which are prescribed by various university and recognized by Madhusudan law university as well.  
  
**(a)(ii)** Candidates belong to general category must have secured a minimum of 45% of marks in aggregate. SC/ST candidates are to secure a minimum of 40% marks in graduation seats are reserved for SC/ST candidates as per Govt. of Odisha guidelines.  
Age : No age bar for taking admission in LLB and LLM course.

(b) A candidate is eligible to apply for admission into 5 years **Integrated B.A.LL.B (Hons.)** Degree course. Any candidate having secured 45% or above marks in the +2 or equivalent examination is eligible for admission. In case of SC/ST candidates this is relaxable to 40%.

Age:- The Candidate should not be more than 20 years of age as on the last date for receipt of application of that particular year. This limit is relaxable up to 22 years for SC/ST candidates.

(c) A candidate is eligible to apply for admission into master of laws (**LL.M**) Two years programme (semester pattern (under choice based credit system) through common P.G. entrance test (SAMS) Student Academic Management System.

Age : No age bar for taking admission in LLM course.

### **SELECTION:**

Selection for admission will be made on the basis of a career cum entrance test. Out of total 100 points, Career Evaluation would carry 50 points and the Entrance Test would carry 50 points.

### **CAREER EVALUATION:-**

For career evaluation the performance of a candidate both in H.S.C as well as that in the +2 or equivalent examination would be taken into consideration. Out of the 50 points, 20 points are earmarked for H.S.C examination and 30 points for +2 examination. Final list for admission will be drawn by adding up the points secured in career evaluation and entrance test. Intimation for admission would be sent to candidates as per their position in the merit list.

3. FEES: The admission fees are subject to modification if necessary.
4. Students seeking admission should apply in the prescribed application from within the stipulated last date fixed by Madhusudan Law University or Govt. of Odisha.
5. The application from duly filled along with the following self attested copies of documents must reach the principal, Adarsha College of Law Angul, on before the last date.
  - a. H.S.C Certificate.
  - b. +2 certificate.
  - c. +3 Degree certificate or equivalent mark sheets.
  - d. +3 Degree Mark sheets
  - e. Caste certificate in case of SC/ST candidates from competent authority.
6. Selected candidates shall produce the following documents at the time of admission:-
  - a. Original college leaving certificate(compulsory)
  - b. Conduct certificate in original from the institution last attended or from a gazette officer in case of private candidates. Private candidates one also to produce provisional certificate from their concerned university inline of college leaving certificate.
  - c. University mark sheet of the qualifying degree examination in original for verification.
  - d. Three passport size photographs of the candidate dully attested.
  - e. Migration certificate in original.
  - f. Original caste certificate in case of SC/ST applicant for verification from competent authority.

- g. In case the candidate is in service, a letter of permission in original from the employee to the effect that he/she has been permitted to study in the college.
  - h. Original H.S.C Certificate or equivalent for verification.
  - i. Provisional certificate /degree of the qualifying examination.
7. Separate Hostel facility for Boys & Girls are available.
8. Prospectus is only for information and this is not a legal document. Subject matter may change without prior notice. Future legal disputes if anyone to be settled only within Angul Jurisdiction.
9. Correspondence in connection with admission should be addressed to the Principal/ Administrative officer Adarsha College of Law,Angul,Odisha .
10. Dress code is compulsory for all the students of the college as per Bar Council of India rules.
11. Admission into college can not be claimed as a matter of right. The decision of the principal in matter of admission is final.
